Participating Store	A Participating Store is any Bottlemart, SignSave and Harry Browns store located in Australia and Thirsty Camel store located in WA that stocks the Eligible Products (defined below) and displays advertising material relating to this Promotion. For the avoidance of doubt, online purchases from a Participating Store are also eligible.
Promotional Period	The Promotion commences at 12:01am (AEDT) on 12/03/2025 and closes at 11:59pm (AEST) on 20/05/2025.
Eligible Entrants	Entry is open to Australian residents aged 18 years or over. Employees (and their immediate families) of the Promoter, its related entities, any prize drawers and any agencies associated with this Promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

Multiple entries permitted, subject to the following: (a) each entry must be submitted separately; (b) a maximum of one (1) entry per person per day is permitted across all entry points; (c) only one (1) entry permitted per Qualifying Transaction (regardless of the amount spent on Eligible Products in that transaction in excess of \$30); and (d) only one (1) Minor Prize (defined below) permitted per person (excluding SA residents).</p>
Draw	<p>5. The Draw will be conducted at 5/9 Fitzpatrick St, Revesby NSW 2212 at 11:00am AEST on 27/05/2025, by way of a random draw. All valid entries received during the Promotional Period will be entered into the Draw. The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn.</p> <p>6. An independent scrutineer will observe the Draw process and announcement of the winners.</p> <p>7. The first valid entry randomly drawn will win the Major Prize (Major Prize Winner).</p> <p>8. Prize(s)	<p>MAJOR PRIZE</p> <p>9. The Major Prize Winner will receive one (1) Harley Davidson Heritage Classic Motorcycle in the colour vivid black. The total prize value is up to \$39,490 including registration, compulsory third party insurance, stamp duty and dealer delivery charges (which may vary State by State). Additional insurance, options and all other ancillary costs are the responsibility of the Major Prize Winner. The Major Prize will be delivered to the Major Prize Winner's home address.</p> <p>10. The Major Prize Winner is responsible for ensuring that all delivery details provided are correct. <p>Privacy and releases</p>	<p>22. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.</p> <p>25.
